John moved, Charlotte seconded to approve the following consent agenda:

Approval of October & November Expenditures

A roll call vote was called for: Earl - aye, John - aye, Charlotte - aye, and Kurt - aye.
Approved unanimously.

Kevin Murray addressed the council to discuss the possibility of changing a city ordinance regarding District Land Use Regulations. Mr. Murray said he represents a church who would like to operate their church and a small daycare facility just off of Highway 91 in a Heavy Commercial zone. He said the ordinance does not allow the consideration of a special use permit for a church in a Heavy Commercial zone, but it does allow the operation of a private school to be considered for a special use permit. Mayor Christensen said the city has a master plan, and there are some residential uses that existed prior to zoning changes, however they are considered grandfathered in for that use. He said a zone change could be considered but this request must go through the Planning and Zoning Commission prior to the City Council. Mr. Murphy said his clients are not interested in changing the zone, but wondered if the ordinance could be amended to allow the request of a special use permit for this type of use. The Council discussed this matter further and instructed BJ to draft an ordinance amendment to allow the consideration of a special use permit for a church in a Heavy Commercial zone.

The Council discussed the ERU's that are calculated for a home based beauty salon. Mayor Christensen said each city can charge how they want, but EIRWWA will assess each city per the established ERU calculation sheet that was adopted. He said the council will have to review the reduction requests and make the decision whether or not to subsidize the cost somewhere else. Sandy said she checked with the other home based beauty salons on the hours that they are open. She said two salons work less than twenty hours per week, and the other two works about 35 hours per week. Sandy said the home beauty salons are almost the only home based businesses that are being charged for extra ERU's since that is the type of business that generates

wastewater. Earl felt the extra ERU cost is just the cost of doing business. He said having a business has associated costs. Earl said he hasn't been in his building all week, but still is paying to have the water, sewer, and garbage. He felt the charge for the ERU should be left as is, and possibly review the reduction request at a later date, when more financial information is available. John suggested the council wait for ninety days and see if any other businesses come forward with a rate appeal, and then a plan could be developed. Earl suggested this matter be tabled for sixty days, and revisit this matter at the last meeting in February. Sandy was asked to schedule a meeting with Dave Noel for more ERU information sometime in February. Charlotte moved, Earl seconded to table this matter until the second council meeting in February so more information could be gathered. Approved unanimously.

John moved, Charlotte seconded to approve the dance license for the Elite Retreat for 2011. Approved unanimously.

Earl moved, Kurt seconded to approve the second hand sales business license for Blue Mule Auctions for 2011. Approved unanimously.

Kurt moved, John seconded to approve the second hand store business license for Hidden Treasures for 2011. Approved unanimously.

Charlotte moved, Earl seconded to approve the second hand store business license for Hidden Treasures II for 2011. Approved unanimously.

John moved, Earl seconded to approve the beer license, carry out only for Food Plaza for 2011. Approved unanimously.

Charlotte moved, Earl seconded to approve the carry out only beer license for Food Plaza for 2011. Approved unanimously.

Earl moved, Charlotte seconded to approve the beer license, carry out only for Hard Times II for 2011. Approved unanimously.

Kurt moved, Charlotte seconded to approve the beer license, carry out only for Shelley Exxon for 2011. Approved unanimously.

John moved, Charlotte seconded to approve a kennel license for Kairn's Shelties on Longhurst Lane for 2011. Approved unanimously.

Kurt moved, John seconded to approve an itinerant business license for Pinnacle Security. Approved three in favor, Earl opposed.

Charlotte moved, Kurt seconded to approve the attached general business license list that is attached as record for 2011. Approved unanimously.

Charlotte moved, Earl seconded to waive the business license fee of \$75 for cabaret for the Elite Retreat for 2011. Approved unanimously.

Sandy said there are two companies that are interested in providing the lease purchase for the new sanitation truck. The truck is being purchased through a piggy back bid through the City of Rupert. Sandy said the Bank of Commerce has provided several lease purchase packages for the city, and can finance the garbage truck at 3.25% interest. She said Cal First Bank is offering 3.45% interest. The Council determined the City will use the Bank of Commerce financial package at 3.25% for the new sanitation truck.

Charlotte moved, John seconded to ratify the cancellation of the December 23, 2010, council meeting due to the holidays. Approved unanimously.

Earl moved, Kurt seconded to ratify the employee Christmas luncheon on December 23, 2010, at noon, when the city offices will close for the holiday. Approved unanimously.

John moved, Earl seconded to ratify the purchase of \$30 Broulim's gift card for all employees for Christmas, and \$10 to \$15 gifts for the committee members. Approved unanimously.

Earl moved, Kurt seconded to ratify the following bicycles that were found by the Police Department as surplus property that will be donated to the Angel Tree organization:

Approved unanimously.

Sandy said Bryon Hogue residing on North Park is not attendance, however he called and stated that mail delivery to the door has been changed to curbside due to the roaming dogs. Mr. Hogue suggested the city might review their ordinances and make more strict regulations regarding impoundment of dogs at large. Earl said he spoke with Alan regarding this matter, and they felt the extra patrol has been helping and the regulations should be left as is for right now. Earl said approximately sixteen dogs were impounded in one month since the mail delivery issues have come up.

Sandy said there will be a Legislative Luncheon in Boise on January 27, 2011. She asked who would be attending this meeting, so she could make the arrangements. Mayor Christensen and John will be attending the Luncheon. Sandy said she will take care of the registration and lodging.

Sandy said she received updated projections for the State Revenue Sharing Revenue and the State Highway Users Revenue for this fiscal year. She said AIC has projected that the original 5 percent increase will not take place, but to use the same figures as last year for the budget.

Sandy said she has been seeking bids for a new telephone system for City Hall. She said she has received one bid, and the second bid is being put together. Sandy said IdeaCom would like to set up a mock system for the office to demonstrate the capabilities. She said she will notify the council by email when the demonstration will occur for anyone who might want to attend.

Chuck said the sewer line project on South Park has been completed.

Chuck said there are Goodfellow Drive donation envelopes available at city hall for anyone wishing to donate.

Chuck said Justin has built some snowmen with lights that are being used at Anderson Park. He commended Justin on his work, and said there may be more Christmas decorations built by the crew in the future.

Alan said Phil Arizola, who is the dog trainer that offered his services to the city for free met with the police department. Alan said some of the information the officers obtained will be usable by the Department. He said Mr. Arizola has some good ideas and is very knowledgeable. Alan said he has also offered his services to the post office.

Kurt said he had the opportunity to attend the INEL Holiday Reception on December 9, 2010.

Kurt said the American Legion will be hosting a free Spaghetti dinner at the Senior Citizens Center on January 14, 2011. He said this will be from 5:30 p.m. until 8:30 p.m. for the military families.

Earl said he appreciates the hard work of the city employees. He commended the police department, and the city crew on the snow removal.

Charlotte said she attended a luncheon hosted by Rocky Mountain Power today. She said there was some good information presented, and there was a discussion regarding energy audits to save power.

John said he appreciates the staff and the volunteer committees for the city. He also commended the Library and other organizations of the city.

Mayor Christensen said he also attended the Rocky Mountain Power meeting. He said he and Charlotte had the opportunity to share a table with Senator Pro-Tem Brent Hill.

Mayor Christensen said there will be an EIRWWA meeting the third Thursday of January at City Hall at 10:00 a.m. He said this meeting was changed from the last Thursday of the month due to the Legislative Luncheon.
