John moved, Charlotte seconded to approve the following consent agenda:

A roll call vote was called for: Steve – aye, Charlotte – aye, John – aye, Lorin - aye. Approved unanimously.

Ken Hopkins, Idaho Bench Inc. addressed the Council to discuss his bench and rest stop business. He said he has had some inquiries and is interested in placing some benches in Shelley. Mr. Hopkins presented a proposal to the Council. He said they will set and maintain the benches at no cost to the city. He said they will pay the city \$5 per bench annually, and will have a minimum of ten benches in Shelley. Mr. Hopkins said he gets paid by the advertising that will be on the benches. He said the city and he must both agree where the benches will be located. Mr. Hopkins said the benches are about three feet high and about six feet long. He said the legs and the back of the benches are made of concrete and intentionally heavy. Mr. Hopkins said the seats are made of 2x6 redwood and the back is plywood with advertising on it. He said advertising is not allowed for alcohol or any item prohibited by ordinance. Mr. Hopkins said the city is held harmless for any liability. He said the benches will be located mostly on street corners and will not impede foot traffic. John questioned Mr. Hopkins about the advertising and asked if the city would be able to use a bench. Mr. Hopkins said one bench will be donated to the city for their use, and typically a customer would have a one-year lease for advertising on a bench. John recommended that Mr. Hopkins work with Rick Anderson and Brent Clark on placement of the benches. BJ said he has reviewed the contract and would like to see a few revisions made before the document is executed. BJ said he will contact Mr. Hopkins to discuss the revisions. This matter was tabled until the next council meeting.

Mr. Wardell was not in attendance.

Devrie Hanson from the Mayor's Youth Committee said the group has received their shirts with the sponsors listed on them. She said the Committee helped with the Chili Cook Off and had a lot of fun. Devrie said the group will be helping with the Goodfellows Drive, and will be entertaining at the Gables.

BJ discussed the City water right application. He said Gary Spackman issued the final order regarding the appeal for the protest of the hearing to reconsider. BJ said basically the order is the same order as initially approved. He said the City has an option that needs to be discussed in executive session pursuant to pending litigation.

It was determined an open house will be held on January 12, 2010 from 6:30 p.m. until 7:30 p.m. to honor Lorin Croft and Steve Cederberg for their service to the community.

John moved Steve seconded to waive the fee of \$75 for the annual dance license for the Shelley Senior Citizen's Center for 2010. Approved unanimously.

John moved, Steve seconded to approve a Beer License (carry out only) for Food Plaza for 2010. Approved unanimously.

Charlotte moved, Lorin seconded to approved a Beer License (carry out only) for Hard Times II for 2010. Approved unanimously.

Steve moved, Lorin seconded to approve a Wine License (carry out only) for Broulims for 2010. Approved unanimously.

John moved, Charlotte seconded to approve a Beer License (carry out only) for Broulims for 2010. Approved unanimously.

Lorin moved, Charlotte seconded to approve a Beer License (carry out only) for Shelley Main Street Exxon for 2010. Approved unanimously.

John moved, Charlotte seconded to approve 93 General Business Licenses (as attached) for 2010, and 5 Specialty Licenses for 2010. Approved unanimously.

John said he received complaints from five business owners regarding the wording of the letter that was sent out with the business license applications for 2010. Sandy said the letter has some wording that was bolded to remind the business owners when the license was due and to be sure and remit the fee. She said the letter was fairly direct, but she really didn't see anything wrong with the letter. John said the goal is to collect data for the businesses and help them economically. He said he will work with Sandy on this matter. The council discussed possibly reducing the renewal fee for a General Business License.

Sandy said there will be a luncheon for the employees on December 24th at noon to celebrate Christmas.

Dawn said there will be a blood drive held on December 30, 2009 at City Hall.

Rick said the crew is continuing to work on the dog pound and will hopefully have the building in service over the next two months.

Frank Hawkins said the Santa Food Drive was held December 7, 2009. He said there were eight boxes for food collected for the food bank. He said there were about 300 people including 250 children. Charlotte thanked Frank for the service he provides to the community.

John said there was a good turn out for the Chili Cook Off. He said Jackie Hanson, Bubba Rick and himself won different categories. John said it appeared everyone had a great time.

John said the benches that may be set by Idaho Bench Company will help the city. He said the city can raise funds and announce events by being able to use the benches for advertising. He asked Rick to work with Mr. Hopkins.

John encouraged everyone to donate to the Angel Tree, Goodfellows Drive and Food Bank if able.

Lorin said the gate on Robald Avenue is constructed and will go into service on this Friday at 4:00 p.m. He said Alan has contacted the media to announce this.

John said a fundraiser is being planned for Ty Swenson, a current Planning and Zoning member. Ty recently had his legs amputated due to a medical condition.

Mayor Christensen thanked everyone who helped with the Chili Cook Off and Tree Lighting Ceremony.

Steve moved, Lorin seconded to adjourn into executive session pursuant to I.C. 67-2345(f).
Approved unanimously.

Lorin moved, Steve seconded to reconvene into regular session. Approved unanimously

Mayor Christensen said during executive session pending litigation was discussed.


